Accepted Medium Categories:

Ceramics, Drawing, Fiber, Folk Art, Glass Jewelry, Metal, Mixed Media, Painting (Acrylic, Oil, Watercolor), Photography, Printmaking, Sculpture (Wood, Metal, etc).

All artists' work need to be consistent with your images. No commercially produced molds, patterns, or castings. No dried flower arrangements, no manufactured belts, buckles, handbags, etc. No ready-made clothing, even if "enhanced" through various media (such as tie-die, painting, or applique, etc.). No "buy/sell" items. Artists must be present to display work, no commercial agents, dealers or salespeople are allowed to tend artwork.

Booth Information:

Artists are responsible for their own display booth. Booth fees for a 10x10 tent is \$200 and a double booth 10X20 is \$400 with a \$20 Jury Fee. No stake down and at least 25lbs weights on each leg of booth. You will have back of booth storage. Multiple electrical hook-ups are available on every street pole in artist market. All booth spaces are on flat pavement or sidewalks. Security will be provided from 7pm Friday night until 7pm Sunday night.

General Information:

All artists' work and their presentation will be evaluated before acceptance to this event. A panel of judges will review applications anonymously. All work you plan to exhibit should be represented in your images with descriptions that will be ready for the jury process. You will be asked to remove any artwork not consistent with the style or quality presented in your application.
